BEFORE YOU GO OVERSEAS

If you are bringing your child along for your overseas job posting, and...

Your child has completed Primary 1 registration

OR

Your child is studying in a primary school, secondary school, junior college, or Millennia Institute





You may apply or renew LOA for your child via an online application form on his/her school's website.



With LOA, your child will remain as a registered student in the school. He/she can be re-admitted directly upon returning to Singapore.



LOA status to be renewed yearly. Fees apply.

National Service (NS) responsibilities if your son is 13 years old or older, and will be residing overseas for 3 months or longer



He can apply, renew, extend, cancel, or check the status of his <u>Exit Permit</u> through the <u>NS Portal</u>.

If your son is 13 to 16.5 years old, residing overseas for 2 years or longer

OR

If your son is above 16.5 years old and residing overseas for 3 months or longer

He will have to provide a bond amount of \$75,000 or 50% of combined annual gross income of both parents for the preceding year, whichever is higher, in the form of a Banker's Guarantee.



Your son may require a new Exit Permit and/or bond if there is a **change in details** in his departure date, place of study, course and/or institution of study. You may apply for a new Exit Permit on the NS Portal.

Pre-enlistees may be granted deferment to pursue full-time overseas studies up to GCE 'A' Level, polytechnic diploma or their equivalent qualifications. Your son should have his **course details** and his latest school letter certifying level and course of study, course commencement and completion dates ready before he starts his application via the NS Portal.



If you are not bringing your child along for your overseas job posting, and...

Your child would like to pursue his/her studies in Singapore while you and your spouse are working or residing overseas



He/she may apply to live in a hostel under the <u>Boarding Award Scheme</u>.

(Only applicable for children studying in a mainstream secondary school, junior college or Millennia Institute. The child and at least 1 parent must be a SC.)

WHILE YOU ARE OVERSEAS



If your child is born overseas



Register your child's birth and obtain the birth certificate from the foreign authorities in the country where the child is born.



Submit a Singapore Citizenship application for your child using your

Singpass account.

NOTE



If your child is born overseas and has obtained Singapore citizenship by descent or registration, he/she must take the **Oath of Renunciation**, **Allegiance and Loyalty (ORAL)** to retain his/her Singapore citizenship status.



When?

The oath must be taken in person after your child turns 21 and before his/her 22nd birthday.

Where?

If your child is overseas: Singapore Overseas Mission If your child is in Singapore: Immigration & Checkpoints Authority (ICA)

When your child is 6 years old (the age for Primary 1 registration)



Update the Ministry of Education (MOE)

You may register your child under the Primary 1 registration process and apply for LOA if your child is allocated a school place but is unable to return to Singapore before January.

Apply for access to the <u>Student Learning Space (SLS)</u>

Child without LOA: Submit this online form to apply

for access to the SLS.

Child on LOA: Request for continued access to the SLS through the school in which your child is registered in.

If your child is coming back to Singapore for a short while and would like to join a school temporarily



He/she may apply for the <u>Immersion programme</u>

It allows your child to attend classes for a specified period to experience school life in Singapore. This will help in easing your child's re-entry to the system.

Approach the school directly to apply for the immersion programme or apply here within 3 months from the intended date of immersion.



13 years old and above

Your son is required to apply for an Exit Permit and/or Bond* to continue residing overseas for 3 months or longer.

*Refer to page 1 for details on Exit Permit and bond

16.5 years old and above

Your son will receive a registration notice for National Service.*

- 1. Follow the instructions to complete his pre-enlistment documentation on the NS Portal.
- 2. Book a medical screening appointment. He will have to return to Singapore for the medical screening at the Medical Classification Centre.
 - *Apply for deferment during the registration process if your son is still studying full-time.

If your son is studying, he will receive letters to complete his pre-enlistment documentation and book a medical screening appointment in Singapore approximately a year before he completes his studies.

• Primary 1 Registration



Primary school education is compulsory for all Singapore Citizens (SC).



You may register your child for Primary 1 if he/she is due for Primary 1 registration (6 years old).

If your son is due for enlistment, he will need to begin his pre-enlistment procedures which includes NS registration, pre-enlistment documentation and medical screening if he has not done so. If he is back for education, please refer to the above information on placement exercise(s).
