

CALL FOR MEMBERSHIP APPLICATION FOR THE ICC SINGAPORE ARBITRATION GROUP UNDER THE AEGIS OF ICC SINGAPORE

Explanatory Note

1. The Singapore Business Federation (“**SBF**”), as the ICC National Committee in Singapore (“**ICC Singapore**”), is calling for Singaporean arbitration practitioners – based locally or abroad – and foreign practitioners based in Singapore to become members of our ICC Singapore Arbitration Group (“Group”).
2. The Group established in 2019 under the aegis of ICC Singapore, aims to (i) represent the Singapore business community in support of the work of the ICC Commission on Arbitration and Amicable Dispute Resolution (ADR); (ii) promote ICC arbitration and other Dispute Resolution Services in Singapore and (iii) develop the breadth and depth of expertise of the regional community through capability building activities related to arbitration and ADR.
3. Members of the Group can enjoy the following benefits:
 - a) Stay connected to a network of arbitration experts and practitioners, forging meaningful relationships at exclusive ICC Singapore events and meetings;
 - b) Have an opportunity to contribute to the planning of ICC arbitration events to develop the arbitration community and sector in Singapore; and
 - c) Be informed of upcoming ICC-related events, new ICC publications and news highlights.
4. Membership is complimentary and on a voluntary basis.
5. The Group will have a Core Committee of up to twenty (20) members, who will set the agenda and work plan of the Group, as well as a Selection Committee of Arbitrators, consisting of a Chair and four (4) other members, who will be responsible for the nomination of arbitrators to arbitral tribunals; but they shall not be allowed to nominate themselves for Court appointments. Both the Core Committee and Selection Committee will be renewed periodically. Final appointments to the Core Committee and Selection Committee will be decided upon by ICC Singapore, in consultation with the ICC Court and its Secretariat.

7. All information received will be kept private and confidential.
8. ICC Singapore, ICC Court and its Secretariat will review your application and confirm your membership in writing. Please note that ICC Singapore, the ICC Court and its Secretariat reserve the right to admit / reject any membership application without giving any reasons thereof.
